Session 1 Tuesday 8:30 AM – 11:30 AM, August 18
Fundamentals of the Texas Property Tax System Part I – This session is designed for initial TDLR registrants. The background of the property tax consulting profession will be discussed along with each phase of the property tax calendar. Instruction will include mass appraisal techniques used by appraisal districts and the contractual duties of the property tax consultant. Session has been approved by TDLR for 3 education hours, 1 legal, 1 property tax consulting related, and 1 appraisal.

Property Tax Law Basic and Ethical Standards – This session discusses the sources of law that enable the taxation of property, explains portions of the Texas Property Tax Code used in the day-to-day business of the Texas Property Tax professional and defines both the TAPTP Code of Ethics and the

TDLR ethical rules. Session has been approved by TDLR for 4 CE hours, 3 legal, one ethics

Session 3 Wednesday, 8:30 AM 5:00 PM, August 19
Fundamentals of the Texas Property Tax System Part II – This session includes instruction in the mass appraisal of business personal property, retail real estate and office buildings, exemptions, and special assessments. Session has been approved by TDLR for 8 CE hours, 4 appraisal, 4 property tax consulting related
